

Terms of Service Agreement

Welcome to WWW.PRIMALNERDS.COM, operated by PRIMAL NERDS, located at OKLAHOMA. By using the website and related mobile website (collectively, the "Websites"), you agree to be bound by these Terms of Service (this "Terms of Service" or "Agreement"), whether or not you register as a member of WWW.PRIMALNERDS.COM ("Member"). If you wish to become a Member and/or make use of the service (the "Service"), please read this Agreement. If you object to anything in this Agreement or the WWW.PRIMALNERDS.COM Privacy Policy, do not use the Service.

This Agreement is subject to change by WWW.PRIMALNERDS.COM at any time, effective upon posting on the relevant website.
